**Procedural
Rules of Interregional Subject Olympiads
of Kazan (Volga Region) Federal University
for 2025/2026 Academic Year**



1. General Provisions

1.1. The present Procedural Rules are developed in accordance with Part 3 of Article 77 of the Federal Law No. 273-FZ of December 29, 2012 "On Education in the Russian Federation", the Order of the Olympiad for School Students, approved by Order of the Ministry of Science and Higher Education of the Russian Federation of No. 566 of June 22, 2022, Regulations on Interregional Subject Olympiads of Federal State Autonomous Educational Institution of Higher Education "Kazan (Volga Region) Federal University" No. 0.1.1.67-08/47/2024 of August 27, 2024 (hereinafter referred to as the Regulations) and determines the order and terms of participation in the Interregional Subject Olympiads of Kazan (Volga Region) Federal University (hereinafter referred to as the Olympiads) in the academic year 2025/26.

2. General Procedure for the Olympiads

2.1. The Olympiads are held in two stages:

- The qualifying stage, which is held in form of tasks to be completed online remotely;
- the final stage, which is held in person, including with the use of distance learning technologies that ensure real-time identification of the participants of the final stage of the Olympiads and control over their compliance with the conditions and requirements of the Olympiads, established by the organizer of the Olympiads

2.2. All stages of the Olympiads are conducted in the subjects listed in Appendix 1 hereto.

2.3. The Olympiads shall be held among students of programs of basic general and secondary general education, including persons mastering educational programs of basic general and secondary general education in the form of homeschooling or self-learning, as well as persons mastering these educational programs abroad, and persons mastering educational programs of secondary professional education in the field of arts.

2.4. Information for the Olympiads participants is published on official web-sites and official social networks accounts.

3. Registration

3.1. Registration is held remotely on the Olympiads web-site or the Olympiads web-site for foreign nationals. Registration is only possible via PC, laptop, or tablet. Registration via mobile devices is not allowed.

3.2. During registration, a username and password will be generated for you to log into your personal account, as well as the ID number of the participant of the Olympiad. The participants are not allowed to transfer the username, password, and ID to third parties. The participants are required to keep their username, password, and ID until the end of the Olympiads. If a participant cannot recover the password and username from his/her personal account, he/she should email the organizers to mpo@kpfu.ru.

3.3. In order to participate in the Olympiads, participants must fill out all fields of the "About me", "Address and Passport" tabs in their personal accounts and sign a Consent to the processing of personal data.

3.4. Electronic forms in personal accounts should be filled out by the participants in Russian.

Foreign nationals participating in the Olympiads should fill out their personal accounts in English in strict accordance with their international passports (in absence of international passports, it is allowed to fill in the information in accordance with the national passport) and in Russian in strict accordance with notarized translation of the international passport (in absence of international passports, it is allowed to fill in the information in accordance with the national passport). Participants are responsible for completeness and accuracy of the data provided in the registration form. It is not allowed to fill data with Caps Lock on. Complaints related to incorrect or incomplete completion of data in a participant's personal account or technical problems that occurred during remote registration will not be accepted or considered by the Organizing Committee after the registration for the final stage. The Organizing Committee has the right to disqualify the participant if incomplete or unreliable information is detected.

3.5. The Olympiads participants of the previous years can use their personal accounts without having to re-register for the 2025/26 academic year, provided that their personal data is updated. Complaints related to the personal account information not being updated after the end of registration for the final stage will not be accepted and considered by the Organizing Committee. The Organizing Committee has the right to disqualify the participant if incomplete or unreliable information is detected.

4. Procedure for the Qualifying Stage of the Olympiads for the Russian nationals

4.1. Participants of the Qualifying Stage shall complete tasks in remotely during one session from 08:00 on November 5, 2025 to 23:59 on November 30, 2025 (Moscow time).

4.2. The Qualifying Stage in Computer Science will be held online in PCMS testing system after the registration on the Olympiads web-site. Tasks are posted in three packages of 5 tasks each and are available from the time of posting until the end of the Qualifying Stage. The score for the Qualifying Stage is calculated as a sum of points received for all tasks of three packages.

Dates of publishing the packages:

- Package 1 - November 5, 2025
- Package 2 - November 13, 2025
- Package 3 - November 20, 2025.

To check the task participants should send the source codes of the program, which are checked on a set of tests, and, based on the number of tests passed, points are awarded for each task. A participant can get a maximum of 100 points for each task. Maximum score for 3 packages of tasks is 1500 points.

The list of available compilers in the testing : C++, Java, Python, Pascal.

4.3. The Qualifying Stage in Design is held in the form of a creative task. During the Qualifying Stage, specified in par. 4.1, the participant shall complete the work in accordance with the instructions to the task and upload completed work in electronic form to the personal account. In the "Qualifying stage" tab of the personal account, the work can be uploaded once; only one file is allowed to be uploaded. The work should not contain any notes unrelated to the task or indicating the authorship of the work (including in the file name). In case of non-compliance with the specified requirements, the Organizing Committee has the right to annul the work.

4.4. In case of a technical failure, a participant can log in to the Olympiad system again if the time set for completing the task is not over.

4.5. In case of a technical failure that made it impossible for a participant to participate in the Olympiad through no fault of his/her own, such participant has the right to send a written request to the Organizing Committee's e-mail mpo@kpfu.ru within three working days after the failure and no later than the day of publication of the rating lists. In this request, a participant must describe in detail the incident that occurred with the attachment of supporting documents (a screenshot of the computer screen, photos and other documents with an error message). If the Organizing Committee recognizes

the cause of the technical failure as valid, it shall assist the participant with repeated participation in the Olympiad.

4.6. For each chosen subject, any registered participant can complete the tasks only once. If a participant has completed the tasks more than once in the same subject, only the first result will be considered in the rating table.

4.7. The duration of the Qualifying Stage session for each subject is counted down from the moment a participant clicks on "Start the Test" and is specified in Appendix 1 hereto.

4.8. If the participant did not click the "Finish and submit for review" button after completing the tasks, the work will score 0 points.

4.9. Answers to the tasks will be available in personal accounts of the participants on the Olympiads web-site on December 1, 2025.

4.10. Rating lists of the participants for each subjects will be published no later than 23:59 on December 5, 2025.

4.11. Applications for appeal will be accepted from December 8 to December 10, 2025 in personal accounts.

4.12. Final results of the Qualifying Stage will be published on the Olympiads web-site by 23:59 on December 19, 2025.

4.13. The winners and awardees of the Qualifying Stage will be determined on the basis of the rating table of the Olympiad participants, formed on the basis of the total score received by a participant, taking into account the results of the appeal.

4.14. The number of winners and awardees of the Qualifying Stage cannot exceed 45% of the total number of participants in each subject.

4.15. Рейтинговые списки и итоговые результаты отборочного этапа Олимпиад по всем профилям публикуются на сайте Олимпиад, согласно ID-номерам участников.

4.16. The participants of the Qualifying Stage that are not included in the list of winners and awardees will get electronic certificates of participation.

4.17. Winners and prize-winners of the qualifying stage of the Olympics receive diplomas of the winner/prize-winner of the qualifying stage of the Olympics in electronic form.

5. Procedure for the Qualifying Stage of the Olympiads for Foreign Citizens

5.1. The qualifying stage of the Olympics will be conducted in the form of completing tasks in a remote format during a single session from 08:00 on December 1, 2025, to 23:59 on December 29, 2025 (Moscow time).

5.2. The Qualifying Stage in Design is held in the form of a creative task. During the Qualifying Stage, specified in par. 4.1, the participant shall complete the work in accordance with the instructions to the task and upload completed work in electronic form to the personal account. In the "Qualifying stage" tab of the personal account, the work can be uploaded once; only one file is allowed to be uploaded. The work should not contain any notes unrelated to the task or indicating the authorship of the work (including in the file name). In case of non-compliance with the specified requirements, the Organizing Committee has the right to annul the work.

5.3. In case of a technical failure, a participant can log in to the Olympiad system again if the time set for completing the task is not over.

5.4. In case of a technical failure that made it impossible for a participant to participate in the Olympiad through no fault of his/her own, such participant has the right to send a written request to the Organizing Committee's e-mail Inter-olympiad@kpfu.ru within three working days after the failure and no later than the day of publication of the rating lists. In this request, a participant must describe in detail the incident that occurred with the attachment of supporting documents (a screenshot of the computer screen, photos and other documents with an error message). If the Organizing Committee recognizes the cause of the technical failure as valid, it shall assist the participant with repeated participation in the Olympiad.

5.5. For each chosen subject, any registered participant can complete the tasks only once. If a participant has completed the tasks more than once in the same subject, only the first result will be considered in the rating table.

5.6. The duration of the Qualifying Stage session for each subject is counted down from the moment a participant clicks on "Start the Test" and is specified in Appendix 1 hereto.

5.7. If the participant did not click the "Finish and submit for review" button after completing the tasks, the work will score 0 points.

5.8. Starting from January 12, 2026, the answers to the Olympiad tasks will be available in the personal accounts of participants on the Olympiad website for foreign citizens.

5.9. Rating lists of the participants for each subjects will be published no later than 23:59 on January 16, 2026.

5.10. Applications for appeal will be accepted from January 17 to January 19, 2026 in personal accounts.

5.11. The final results of the Qualifying Stage will be published on the Olympiad website for foreign citizens no later than 23:59 on January 23, 2026.

5.12. The winners and awardees of the Qualifying Stage will be determined on the basis of the rating table of the Olympiad participants, formed on the basis of the total score received by a participant, taking into account the results of the appeal.

5.13. The number of winners and awardees of the Qualifying Stage cannot exceed 45% of the total number of participants in each subject.

5.14. Ranking lists and final results of the Qualifying Stage of the Olympics for all profiles will be published on the Olympiad website for foreign citizens according to the participants' ID numbers.

5.15. The participants of the Qualifying Stage that are not included in the list of winners and awardees will get electronic certificates of participation.

5.16. Winners and prize-winners of the Qualifying Stage of the Olympics receive diplomas of the winner/prize-winner of the Qualifying Stage of the Olympiad in electronic form..

6. Procedure for the Final Stage of the Olympics for Citizens of the Russian Federation

6.1. The Final Stage is held from January 12 to February 8, 2026 in accordance with the schedule approved by the Order of the Rector of KFU. The schedule of the Final Stage will be published on the web-site by 23:59 on December 08, 2025.

6.2. The start and the end of all the Olympiad events are indicated in Moscow time.

6.3. The profiles of the Olympiad included in the list of the Russian Council of School Olympiads for the current academic year are conducted only in person at the venue of Kazan Federal University (KFU) and its partners. Profiles of the Olympiad not included in the list of the Russian Council of School Olympiads for the current academic year will also be conducted in person, including the use of remote technologies..

6.4. The following participants shall be qualified to participate in the Final Stage:

- winners and awardees of the Qualifying Stage of the current year;
- winners and awardees of the Final Stage of the previous year in corresponding subject, continuing their study under educational programs of basic general and secondary general education, as well as in the form of family education, self-education, mastering these educational programs abroad, or mastering educational programs of secondary vocational education in the field of Arts, skipping the qualifying stage.

6.5. Participants are allowed to the final stage upon presenting the originals of the following documents:

- a) a document proving identity: a passport (if the participant is 14 years old or older) or a school certificate with the participant's photograph (if the participant is under 14 years old);
- б) the title page of the participant's work for the final stage, printed from the personal account on the Olympics website, indicating the following information:
 - Participant's ID number;

- Full name exactly as stated in the identity documents;
- Date of birth;
- Contact phone number;
- Number of Insurance Number of Individual Ledger Account;
- Number and series of the identity document (passport of a citizen of the Russian Federation/birth certificate);
- Name of the locality and educational organization (including for participants pursuing general education programs of basic general and secondary general education in the form of home education);
- City where the in-person stage is taking place.

6.6. For participants of the final stage, from December 23, 2025, to January 11, 2026 (inclusive), a remote procedure for selecting the city of participation in the final stage will be organized in their personal accounts. Participants who do not select a city of participation and arrive at the venue of the final stage without prior notification to the organizing committee are not guaranteed a workspace.

6.7. The final stage for the profile "Informatics" will be conducted in the PCMS testing system, where 5 tasks will be provided. To check the task participants should send the source codes of the program, which are checked on a set of tests, and, based on the number of tests passed, points are awarded for each task. A participant can get a maximum of 100 points for each task. The list of available compilers in the testing system: C++, Java, Python, Pascal.

7. Procedure for the Final Stage of the Olympics for Foreign Citizens

7.1. The final stage of the Olympics will be held from February 2 to February 10, 2026, in accordance with the schedule for the Olympics approved by the order of the rector of Kazan Federal University (KFU). The schedule for the final stage will be published on the Olympics website for foreign citizens no later than 23:59 on January 16, 2026.

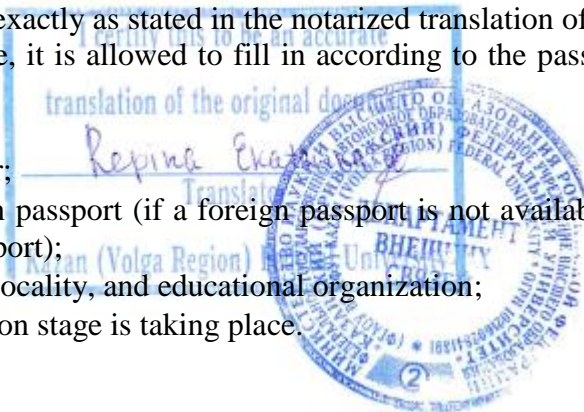
7.2. The start and the end of all the Olympiad events are indicated in Moscow time.

7.3. The following participants shall be qualified to participate in the Final Stage:

- winners and awardees of the Qualifying Stage of the current year;
- winners and awardees of the Final Stage of the previous year in corresponding subject, continuing their study under educational programs of basic general and secondary general education, as well as in the form of family education, self-education, mastering these educational programs abroad, or mastering educational programs of secondary vocational education in the field of Arts, skipping the qualifying stage.

7.4. Participants are allowed to the final stage upon presenting the originals of the following documents:

- a) document proving identity;
- б) the title page of the participant's work for the final stage, printed from the personal account on the Olympics website for foreign citizens, indicating the following information:
 - Full name in English exactly as stated in the foreign passport (if a foreign passport is not available, it is allowed to fill in according to the passport of the citizen of the country);
 - Full name in Russian exactly as stated in the notarized translation of the foreign passport (if a foreign passport is not available, it is allowed to fill in according to the passport of the citizen of the country);
 - Date of birth;
 - Contact phone number;
 - Number of the foreign passport (if a foreign passport is not available, it is allowed to fill in the number of the citizen's passport);
 - Country, name of the locality, and educational organization;
 - City where the in-person stage is taking place.



7.5. For participants of the final stage, from January 24 to January 30, 2026 (inclusive), a remote procedure for selecting the format of participation in the final stage will be organized in their personal accounts. Participants who do not select a city of participation and arrive at the venue of the final stage without prior notification to the organizing committee are not guaranteed a workspace.

8. Procedure for Conducting the Final Stage of the Olympiads at the Venue

8.1. The venues for the final stage of the Olympiads are approved by the order of Kazan Federal University (KFU).

8.2. Official representatives of Kazan Federal University (KFU) from among the employees of the main structural divisions of KFU are appointed by order of KFU for conducting the final stage of the Olympiads at the venues.

8.3. Official representatives of KFU receive delivery packages containing tasks and distribution materials for each participant of the Olympiads from the organizing committee for the profile of the final stage.

8.4. The delivery package includes tasks for each profile of the final stage. The distribution materials contain the following forms: tasks, Form No. 1 for answers, Form No. 2 for answers, and a draft.

8.5. The delivery package is opened by the official representative of KFU at the venue of the final stage of the Olympiad in the presence of the participants.

8.6. Completed works are collected by the official representative of KFU into separate packages by profile and sealed.

8.7. The final stage of the Olympiad concludes with the preparation of a report on the conduct of the Olympiads, indicating the date and location of the event and the number of participants. If necessary, a report on violations identified during the organization and conduct of the final stage of the Olympiad is filled out. The reports are signed by the official representative of KFU.

8.8. Completed works are collected and sealed by the official representatives of KFU and delivered to the organizing committee for encryption and transfer to the jury.

8.9. Official representatives bear personal responsibility for the safekeeping and non-disclosure of the tasks received from the organizing committee.

9. Rules of Conduct for Participants During the Final Stage of the Olympiads

9.1. The duration of the final stage of the Olympiads for each profile is specified in Appendix 1 to this Procedural Rules.

9.2. On the day of the final stage of the Olympiads, participants must arrive at the venue no later than 40 minutes before the start of the Olympiads for seating in the auditoriums and receiving instructions.

9.3. Participants receive the answer sheet and draft sheets in the auditorium. The use of paper brought by participants or provided by other individuals is not allowed.

9.4. Participants who arrive no more than 30 minutes late for the start of the Olympiads are allowed to participate, but their time for completing tasks is not extended. Participants who arrive more than 30 minutes late are not permitted to participate in the Olympiads.

9.5. In the event of unforeseen circumstances (such as force majeure, unfavorable sanitary and epidemiological conditions in the country, the introduction of special regimes, etc.) that hinder the conduct of the Olympiads, the organizing committee may decide to change the start and end times for participants to complete the Olympiad tasks (provided that necessary measures to protect the confidentiality of the Olympiad tasks are observed) or to cancel the event.

9.6. During the Olympiads, participants are prohibited from communicating and exchanging any materials, items, and tasks, copying from others and allowing others to copy from them, standing up without the permission of the organizers, having communication devices (mobile phones, smartwatches, headphones, and other communication devices), electronic computing devices,

programmable calculators, photo, audio, and video equipment, reference materials, written notes made on any medium, and other means of storing and transmitting information, except for special technical means for participants with disabilities and means permitted for use by participants during the Olympics, the list of which is determined annually in conjunction with the methodological commission and the organizing committee, approved by the decision of the organizing committee, and published on the Olympics page.

9.7. The use of the materials, items, and means specified in paragraph 9.6 of the Regulation is prohibited both in the auditorium and throughout the entire building for the duration of the Olympics until the time allocated for completing the Olympiad task has ended.

9.8. If there are signs indicating that a participant possesses unauthorized materials, items, and means listed in paragraph 9.6 of the Procedural Rules, the organizer may require them to be presented or demonstrate their absence. The participant is obliged to comply with the organizer's request. In case of refusal, the organizer has the right to disqualify the participant from further participation in the current year's Olympics without the right to appeal the decision made.

9.9. Participants in the final stage for the "Mathematics" profile are prohibited from using any calculators.

9.10. Upon the expiration of the allotted time, participants must cease work on the task; otherwise, it will be considered a violation of the rules of participation in the Olympiads.

9.11. Organizers will accept a participant's work for review upon presentation of an identity document. If the identity document is not available, the work must be submitted but will not be subject to review.

9.12. In the auditorium, participants are allowed to have only a transparent plastic bottle (with a capacity of no more than 500 milliliters) containing non-carbonated mineral water, chocolate in non-crinkly packaging, and medications.

9.13. Participants in the final stage must complete their work using only a black gel pen. The use of ballpoint pens or pens of other colors is prohibited. The work must be neatly presented and written in a legible handwriting. Corrections in the work are not allowed.

9.14. If necessary, a participant is allowed to leave the auditorium no more than two times and for no more than 6 minutes, accompanied by a supervisor.

9.15. Upon presentation of a health certificate, the requirements specified in paragraph 9.14 may be revised in favor of the participant.

9.16. Leaving the auditorium is permitted one hour after the start of the Olympiads. Participants are prohibited from leaving the auditorium 30 minutes before the end of the Olympiads.

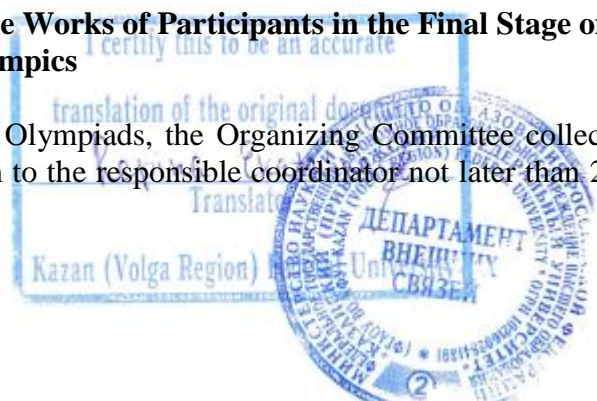
9.17. Participants in the final stage have the right to submit their work early, but no less than 30 minutes before the end of the Olympiads. Submitting work less than 30 minutes before the end of the Olympics is prohibited.

9.18. A participant in the final stage may only take the Olympic task after the time for the Olympiads has ended.

9.19. In the event of a participant violating the Rules of Conduct during the final stage of the Olympiads, authorized officials of the organizing committee will draw up a report on the violation and the participant's disqualification from the corresponding stage of the Olympiads. In the case of an in-person format of the Olympiads, the participant will also be removed from the venue. If the fact of violating the Rules of Conduct becomes known after the end of the corresponding stage of the Olympiads but before the final results are approved, the participant may be disqualified, and their result may be annulled based on the jury's protocol with a decision to disqualify the participant.

10. Procedure for Checking and Evaluating the Works of Participants in the Final Stage of the Olympics

10.1. At the end of the final stage of the Olympiads, the Organizing Committee collects the completed works, codifies them and submits them to the responsible coordinator not later than 2 days from the day of the final stage of the Olympiads.



10.2. The checked works are published in the personal accounts of the participants on the next day after the rating lists for each profile. The works done by the participants of the profiles “Design” and “Informatics” are available only on request.

10.3. The responsible coordinator hands the encrypted works to the jury, the jury checks, evaluates and scans them within 10 to 20 working days.

10.4. For each completed task a score is given in points. The maximum number of points for each profile is 100. The maximum number of points for the “Informatics” profile is 500.

10.5. Drafts are not encrypted or checked.

10.6. The Organising Committee together with the Jury prepares a draft protocol with the results and rating lists of the participants based on the sum of points received by the participant for completing the Olympiad tasks on the basis of the checked works.

10.7. The protocols with the results are approved by the chairman and members of the Jury.

10.8. The Organising Committee shall publish the rating lists of the participants for each Olympiad profile on the Olympiad website no later than 25 working days from the day of the final stage.

10.9. Applications for appeal shall be accepted within three days from the date of publication of the ranking lists of participants.

10.10. Appeals are accepted only from the e-mail accounts registered in the personal account on the Olympiad website.

10.11. Appeals will only be accepted in Word or PDF format.

10.12. After the Appeal Commission has conducted the appeal procedure, the Jury prepares final protocols signed by the Jury members and the Jury President, determines the candidates for winners and prize-winners.

10.13. The complete package of documents shall be sent to the Organising Committee.

10.14. The results of the final stage of the Olympiad are published on the Olympiad website

10.15. The final protocols of the Olympiads shall be published on the Olympiad website no later than March 31, 2026.

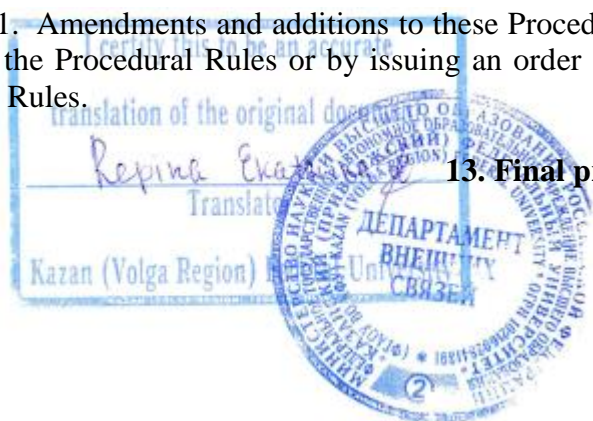

13. Final provisions



13.1. These Procedural Rules shall be registered in the Document Management and Control Department. These Procedural Rules shall be subject to mandatory distribution, which shall be carried out by the Document Management and Control Department in accordance with the procedure defined by the KFU Office Management Instruction.

13.2. These Procedural Rules shall be posted on the website of the Centre for Work with Gifted Schoolchildren of the Department of Education.
